## **INSURANCE DEPARTMENT: 1332 WAIVER REINSURANCE PROGRAM—PROGRAM PARAMETERS; NOTICE 2021-11**

The Insurance Department announced that the federal Department of Health and Human Services' Centers for Medicare and Medicaid Services and the federal Department of the Treasury approved the Pennsylvania Insurance Department's 1332 waiver application, effective January 1, 2021, to December 31, 2025, with a provision for possible extension.

The reinsurance program is a claims-based, attachment point reinsurance program that will reimburse health insurers for claims costs of qualifying Affordable Care Act-compliant individual enrollees, where a percentage of the claim's costs exceeding a specified threshold will be reimbursed.
